Agenda Item #3. Clarification of Policy on Background Checks for Summer Seminar Instructors – Executive Director Kim Kiick

ANA Staff has requested clarity to determine how frequently to conduct the background checks mandated by the new policy. The Executive Director suggests a frequency ranging from 3-5 years.

(180612 OS 4) MOTION by Governor Highfill, second by Governor Ross that the American Numismatic Association shall institute a policy effective September 1, 2018 requiring all adult(18 years old or older) Summer Seminar instructors and counselors to submit to a background check prior to participating in the event.

MOTION by ______, second by _____ to amend the Summer Seminar Background Check Policy to include that such checks should occur at least once every years.

Discussion: The Board consensus was to continue conducting yearly background checks and no motion was made to modify the policy.

Agenda Item #4. Bylaws Committee Feedback on Proposed Board Conduct Policy – General Counsel Hollie Wieland

In December, the Board asked the Bylaws Committee for feedback on the following proposed policy:

Board Members' Obligation to Disclose Allegations of Misconduct

A Board Member shall notify the Board of Governors and Executive Director of any written allegations of misconduct against them, regardless of monetary value, which may create conflicts of interest, give rise to an appearance of impropriety for the ANA or in any way adversely impact the ANA Brand. A Board Member shall notify the Board of Governors of any written allegations of misconduct as soon as the Board Member has knowledge of the allegations. The Executive Director shall notify the Board of Governors of any written allegations of misconduct involving a Board Member as soon as the Executive Director has knowledge of the allegations. After receiving notice of the written allegations of misconduct, the Executive Committee shall determine if a Special Meeting should be called to immediately address the allegations or if the allegations can be addressed in the next regularly scheduled Executive Session Meeting of the Board of Governors. If the allegations of misconduct involve a Member of the Executive Committee, then the Board Member against whom the allegations are made shall be excused from discussions relating to the allegations. During the Executive Meeting in which the allegations are discussed, the Board of Governors will consider what, if any, further action should be taken to protect the ANA's interests. If necessary, the Board shall issue notice pursuant to Section 15 of the Board Member Code of Ethics.

Discussion: Counselor Wieland will send the policy to the Bylaws & Ethics Committee for their action.

Agenda Item #5. Presentation of Plan to Promote "Adopt-A-School" in School Systems – Governor Ralph Ross

Discussion: Governor Ross discussed options to promote the Adopt-A-School kit initiative. Executive Director Kiick advised that the initiative was being worked through the local ANA clubs. She was asked to review the approach.

Governor Ross was asked to draft a letter of introduction to send the kits to target schools.
