Agenda Item #5. Membership Dues Rate Changes – President COL Steven K. Ellsworth

In its January meeting the Board approved an increase to the Gold/Digital level of membership (those who receive the magazine online). The new dues rates approved by the Board are shown in Grid 1. Grid 1.

However, Grid 1 contained a formatting error when it was copied from the ANA's Policy Manual and appears to indicate that Senior Gold members receive a discount. This is incorrect, and a motion is needed to approve the rates in accordance with the Membership Committee's original intent (shown in Grid 2).

Governor Lyon expressed concern that the dues increase will result in members dropping their membership.

Governor Mishler expressed his concern about the membership loss and also was concerned that the digital membership resulted in losing revenue.

Executive Director Kiick advised that there was a plan to gradually increase digital dues to the Silver level.

Past Governor Boling asked when the YN upper age limit was reduced to 18 years old. Executive Director Kiick advised that the change was made in 2011.

In 2019, we offered tickets priced at \$100 before our cutoff date (\$110 after). We sold 131 tickets at the \$25 discount rate.

The Finance Committee recommends that the banquet ticket discount be changed to 1 ticket at 50% of its published price/face value and that we eliminate the discount for our banquet award recipients' guests.

(200229 OS#5) MOTION by Governor Mishler, second by Governor Garrett to offer one (1) discounted banquet ticket at the rate of 50% of its face value for all eligible categories except that banquet award recipients will receive only their free ticket with no discount offered to their guest.

Discussion: Treasurer Baber reviewed the background on the motion.

Governor Lyon was concerned about the cost to exhibitors.

Past Governor Boling commented that since the exhibit awards are no longer presented at the banquet, increasing the cost of tickets to exhibitor can cause exhibitors to stop attending the banquet.

Agenda Item #7. Discussion of Great American Coin Hunt – Executive Director Kim Kiick with Rob Oberth, President of RoundTable Trading

Executive Director Kiick advised that the Roundtable formed a 501 c (3) allowing a joint effort. The Board had no objections to the effort.

Town Hall Discussion with Membership.

Past Governor Boling asked how members are notified of open session board meetings and if members can call to participate in in the meeting. President Ellsworth commented that the meeting minutes are published on our website after approval.

Past President Garrett commented that we may investigate podcasts.

There was discussion on if the membership could be given 30 days to comment and request Board action after the minutes are published on the website.

Executive Director Kiick commented that it may consider sending the open session agenda to the Advisory Council prior to the meeting.

Georgia Numismatic Association President Tom Youngblood thanked the ANA for holding the NMS in Atlanta.

Past Vice President Don Kagin advised that the NMS auction exceeded expectations having over \$3.3 million.
