Agenda Item #5. Funding for Publication of an America the Beautiful Quarter Series Book – Executive Director Kim Kiick

Former Numismatist Editor in Chief Barbara Gregory is working with Arlyn Sieber to produce a collection of reprints of his articles chronicling the America the Beautiful quarter series that appeared in the magazine during Gregory's tenure. The requisite licensing application has been submitted to the US Mint and is pending approval.

With permission from the board, use of the Revolving Publishing Fund (an endowment established in 1995 for the specific purpose of publishing numismatic books and brochures) would enable us to produce the book. The current balance of the fund is \$88,000. Costs for labor and printing would be \$8,205 + \$500 to produce the digital edition (\$8,705). The ANA will retain revenue from sales of the book.

Revolving Publishing Fund (August 13, 1995): Motion by Bressett, second by Carmody/Swiatek, That insomuch as the President has recommended that we more closely define the hobby enhancement dinner honoring Q. David Bowers according to a stratagem developed by Vice President Bressett, that the 1995 Hobby Enhancement Dinner at the 104th ANA Anniversary Convention be used as startup costs for a revolving endowment fund of \$50,000 for developing a numismatic book and brochure publishing effort. The balance of the fund is to come from Endowment as to be consistent with the five-year plan. Vote: Passed – 6 Yes, 3 No (Lisot; Pittman; Wilson)
