### Agenda Item #1. Approval of Open Session Minutes - President Ralph Ross

#### Agenda Item #2. Treasurer's Report – Treasurer Larry Baber

Treasurer Baber and CFO Howe, related that the auditor was at ANA Headquarters conducting the audit. They expect a *final copy of the audit report April 9, 2022 (R1)*. They also advised that our cash flow was better than expected, with approximately \$1.3 million in our bank account, and we may not need to sell stock for operating cash this fiscal year.

#### Agenda Item #3. 2023 NYINC Commitment - President Ralph Ross

The purpose of this motion is to recapture for 2023 the objectives that had been discussed and established for participation at these events in 2022. The ANA needs to establish a higher profile where the world/international community is concerned. – CM

(220208 OS#2) MOTION by Clifford Mishler, second by Shanna Schmidt, to commit the ANA board to attendance and participation at the NYINC and ANS Gala events in January, 2023. **Discussion:** President Ross stated that this was a grand opportunity to enhance relations between the ANA and ANS.

Governor Schmidt asked Governor Mishler to report on his attendance at the 2022 NYINC. Governor Mishler commented that the venue and facility were fine (he heard no complaints from other attendees) but that oversea attendee's attendance was limited due to COVID related issues. He feels that the ANA is too focused on U.S. coins and currency, and attendance at the NYINC helps broaden the focus and demonstrates the broadened focus to foreign and ancient collectors and dealers. He complimented Curator/Museum Director Mudd on his presentation. Governor Schmidt related that she had heard that the dealers had a successful show She had heard that Curator/Museum Director Mudd's talk at the NYINC was well received but attendance was limited due to COVID related issues.

Curator/Museum Director Mudd indicated he observed that approximately 85% of the dealer tables were filled, that the dealers were happy to see ANA involvement at the show, and that he would be willing to present a talk at the next NYINC. He commented that the show had multiple auction houses holding auctions or displaying future auction lots, including some virtual auctions.

Governor Garrett sat in on several auctions and thought the sales were successful.

## Agenda Item #5. The Astronauts Memorial Foundation – Governor Mark Lighterm

President Ross related that Executive Director Kim Kiick, Governor Lighterman, Bob Mellor and he visited the Foundation and toured the KSC facility.

Governor Lighterman advised that Bob Mellor had coordinated the visit, that they discussed the educational aspects of using Gene *Hynds*' space related token and medal collection as a basis to enhance the educational aspects, that they were looking into using Lighterman and Mellor to teach aspects of science and STEM, and that they thought the effort would cross promote the ANA and the Foundation. He indicated that Bob Mellor has been placed on the AMF committee as a special advisor not only for this project and other projects.

Executive Director Kim Kiick commented that the effort would enhance synergy between the organizations, involve minimum risk, and provide excellent public awareness of both organizations.
