Counselor Wieland advised that she had nothing to report.

Agenda Item #6. Joint Venture between ANA and Indian River State College – Governor Mark Lighterman

The Treasure Coast Coin Club, through their connection to Indian River State College by those involved with both the club and the college, started donating numismatic books that the public can use as a reference. Gene Hynds' family felt that the ANA had most of his books already [in their collection] (with the cost of shipping them to headquarters as a donation more than they were willing to spend) and felt that the college, if they wanted them, would be a perfect home, and the books would remain within the state. After discussion with those involved, it was determined that there are many collectors who fall into this category. Out of this—using the books in the Hynds library as a donation to seed a project—came the idea that with both the college's help and the ANA's support we could set up a trial ANA outreach within local colleges for collectors to have access to research material, free to the public. There would be no cost to the ANA except the sharing of information to let members know such a place exists. The college has already signed on to the idea, and with the ANA board's approval, we can work out any details that both sides need to agree upon. Further updates will be provided to the board as things progress.

(220818 OS#4) MOTION by Governor Lighterman, second by Governor Mishler to fully support a trial joint venture between the ANA and the Indian River State College in establishing a remote ANA numismatic reference section in their library, open to the public for numismatic research.
