**Discussion:** President Ross provided an overview of the focus for the committee.

Governor Mishler commented that the committee needed a non-board or staff member representative.

Vice President Boling felt the committee needed a *dealer (R1)* representative.

Governor Oberth declined to be a committee member given the current situation on the Dealer Day theft issue.

President Ross indicated that he planned to add Governor Garrett to the committee after her family wedding.

Governor Ellis thought the committee needed a non-board coin dealer representative. Counselor Wieland suggested that the committee could invite non-board dealers to be advisors or committee members as appropriate at a later date.

Vote Passed 8-0-0 (1 absent, Governor Schmidt)(R1)

### Agenda Item #4 Re-examination of Exhibitor Bourse Access Policy – Executive Director Kim Kiick & Events Director Jennifer Ackerman

An impromptu item of business decided at the World's Fair of Money® appears to have set the exhibitors' schedule for bourse access to match Early Bird access. This action will prohibit exhibitors' access during their customary set-up schedule, removing an entire day.

If desired, the board may rescind the motion since the policy change has not yet taken effect.

MOTION by Governor Mishler, seconded by Vice President Boling to allow exhibitors on the bourse floor at the same time as the people with Early Bird

passes are allowed on the bourse floor.

Discussion: None further.

Vote Passed 8-0-0 (Governor Lighterman abstained)

Discussion: Executive Director Kiick asked for clarification of the motion.

Governor Mishler addressed the issue of exhibitors leaving the exhibit area to buy and sell at the dealer tables area (bourse) during dealer setup prior to the time early birds are allowed onto the bourse.

Governor Lighterman was concerned about enforcing a policy reflecting the motion as the Exhibit Committee isn't staffed to do so. He did advise that exhibitors needing to setup their exhibits prior to dealers accessing the show on dealer setup day are escorted to/from the exhibit area by the committee until the dealers are allowed to access the bourse area.

Vice President Boling asked if exhibitors were allowed in the dealer table area during Dealer Day or during dealer setup hours.

Events Director Ackerman advised that only dealers with tax identification numbers are allowed on the bourse on Dealer Day. She also advised that exhibitors are not allowed in the bourse prior to allowing early birds in the bourse. Finally, she commented that the exhibitor ribbon can be changed to include the show specific information as name/date of the show similar to the early bird ribbons.

Vice President Boling commented that the changed ribbons are needed for exhibitors and judges who need to access the exhibit area prior to and after the bourse closes for the day.

After discussion the board consensus was to keep the motion as made until policies, procedures and rules are in place to clarify and implement the intent of the motion.
