**8. Proposed ANA Award Policy Criteria Committee – Governor Walter Ostromecki**

Ostromecki:

The establishment of a Committee charged with the duty to develop the standard policy criteria for the naming of all ANA awards.

Said committee will, within 90 days, bring their policy recommendations back to the Board for review, discussion, and adoption. The suggested composition of the committee (of no more than five) should include at least one member from the ANA Staff, Advisory Council and Board of Governors. Said committee would be ad hoc.

**9. Proposed Convention Medal Judging Committee – Governor Walter Ostromecki**

Ostromecki:

- On the current process/selection for how the ANA's annual World's Fair of Money Medal is conducted, it is my understanding this competition and contracted designer is done internally at ANA Headquarters with the yearly submitted designs being posted on the breakroom wall (?) and voted upon only by staff solely. If it's truly a design competition, it should be done through a committee of at least five individuals. Staff can certainly be a part of said committee, but not from my understanding, the sole judging source.
- The new committee should also be charged with the responsibility to develop a standard Convention Medal Judging Policy which would be reviewed, edited, and

approved by the Board. The suggested committee composition (of no more than five individuals) should include at least one member from the ANA Staff, Advisory Council, Exhibit Committee, and Board of Governors. Said committee could be either ad hoc or standing.

Background notes:

- For many years, the coordination of convention medal design and selection has been a responsibility of staff. The Membership Director, who in the past has also served in Enterprise (our former sales division), recognized the importance of selecting an appealing design to balance the objectives of promoting sales of the convention medal as well as creating a collectible piece of convention memorabilia.
- Generally, host clubs provide feedback and suggest a narrative for designs using elements inspired by the host city, its geographical and/or historical themes, and its numismatic ties. In some years, only one design is developed.
- For the 2016 Anaheim WFM, 14 artists were invited to submit designs; four designs were received. Due to the number of designs provided, ANA staff was asked to assist in making this year's selection—an opportunity that does not occur every year.
- ANA staff includes numismatic experts, collectors, and those versed in ANA history as well as persons with qualifications in art and aesthetics. The staff was not provided information on the artists, permitting them to make an impartial choice based solely upon their evaluation of the designs.

## 11. Naming the ANA Medal of Merit as a Memorial to Chester L. Krause – Governor Walter Ostromecki

Colloquy (Ostromecki):

- Currently, a number of top ANA Association Awards are unnamed in honor of an individual whose name signifies greatness and high regard. One such award is the ANA Medal of Merit. It would be the most prestigious and befitting memorial tribute to the man and friend so many of us knew as Chester L. Krause. This annual ANA award is presented to an honoree in the form of a medal which could be re-designed, if the BOG deems so, to bear a likeness of him.
- Simply changing the name on the current Farran Zerbe Award to Chet Krause Award would dishonor Mr. Krause by equating his name and character with another, not to mention only cause disruption/confusion as well as possible “tensions” within others and, perhaps, our ANA membership.
- Chet was a noble man of distinguished moral character held in high regard by the numismatic community for nearly 70 years. His unique achievements and contributions to the numismatic hobby were truly priceless, extraordinary and meritorious—straight from his heart. His name on the ANA Medal of Merit would be a lasting memorial, a fitting tribute to his admirable distinguished character, and the high regard in which the numismatic hobby and the ANA defined him by.
- Why the Medal of Merit? Currently this award is presented in “medal and pin format” to a recipient(s) for extraordinary and distinguished numismatic service, achievements, selfless years of volunteer service to the numismatic hobby and the ANA. A new medal to replace the current ANA Medal of Merit could be designed bearing the likeness of Chet with the inscription “The Chester L. Krause Memorial Medal of Merit”. There would only be some costs associated with the artist’s design. These could be offset by a yearly or whatever donor/sponsor of the award.
- Webster's defines the words “merit” or “meritorious” as follows: having a great character quality or features; deserving of high regard and great respect; admirable;

distinguished; priceless; having an ethical moral character of distinction; deserving esteem, respect and honor; having cardinal value and excellency of virtue. All these words or phrases describe/define the man we all knew as “Chet”.

- Mike Fuljenz, a top tier coin dealer and owner of Universal Coin & Bullion, has committed to continue his financial sponsorship of the Farran Zerbe Award (already announced in a joint Universal–ANA Press Release) through 2018; that's three years. He's sponsored the award since 2012 and been a regular ANA Convention sponsor for many years.
- Action to now suddenly change the Zerbe name to another name *for whatever* concerns should have been done decades ago. The same might apply to other various awards currently given out in the name of.... We should drop and abandon any rename of the award.
- If the Zerbe Award were to have a name change there would be unknown costs involving a design artist, the die, and the striking of new medals. Any current on hand inventory of Zerbe medals would need to be melted down. Cost? The cost of gold bullion is at a current market high.
