The second place theme was "Be a History Teacher: Give a Kid a Coin!" submitted by Greg Roberts of Glendale, Wis.

The ANA encourages all clubs to be active during National Coin Week this year. There will be an abundance of resources available in early February on www.money.org, including sample press releases, a proclamation, tips for getting involved at local schools and libraries, an interactive promotional flyer and a two-panel exhibit in PDF format. Just select "National Coin Week" from the "Numismatic Events" drop down menu.

Other activities planned for April include a treasure hunt where children will be asked to find five different types of coins and other objects. Prizes will be awarded on a local and national level to youth who participate. News from Around the Country

New Mexico

The Albuquerque Coin Club has been very active over the last several months. Membership has grown to over 150 members with normal attendance at monthly meetings of from 60 to 70 members. The September meeting had a record 91 members present. Six times a year there is also a second monthly meeting that is purely educational with no business meeting. Since June, the monthly newsletter has been sent via e-mail in PDF format to those members who requested it. This saves the club about \$9.00 per year in printing and postage for each member who elects this form of delivery. So far, about 45% of the membership receives their newsletter in this format. {Editor’s note: A number of other clubs are also doing this, for example the Tacoma-Lakewood Coin Club here in Washington State.}

The club applied for a 501(c)(3) non profit designation from the IRS, and was awarded it after about a year of work. This designation could be very beneficial to all clubs, but it does take quite a bit of work to get it.

A separate YN club was started this year with 11 YNs attending the last meeting. A substantial donation for funding the ACC YN program was received which was directly related to the IRS 501(c)(3) ruling. This will help to fund our YN program for many years into the future.

Twice each year the ACC holds a coin show. The fall show was just held with 50 dealers present and with 99 tables of numismatic only items. Attendance was great, and more than 80% of the tables for the next show in April 2008 were sold before the fall show closed.

It has been a very busy time, but there have been many more volunteers for club activities than in years past. Several groups of members are working together to accomplish the many tasks needed to keep this large of a club going.

Cheyenne Fall Coin Show Big Success — Cheyenne's 2nd annual fall coin show, held September 21-23, 2007, was a big success. There were 48 tables with 29 dealers from as far away as Silverdale, Washington and Water Valley, Mississippi. There were about 420 people in attendance for the 3-day show. Ken Byrd (Kenneth L Byrd) and Larry Johnson (Gresham's Law), both from Colorado Springs, Colorado, had great shows and said that they will return. Bruce Foss (Bruce's Coins) of Rollette, North Dakota and Lee Roe (Hilltop Coins) of Cascade, Iowa said that it was a good show. Friday night about 15 dealers got together at a local restaurant (Twin Dragon) and had a lively dinner. ANA Vice President Patti Jagger Finner (Iola, Wisconsin) did a Coin Collecting Merit Badge Clinic for 15 Boy Scouts.

On Saturday morning the show opened with a visit from Jennifer McCafferty, Miss Wyoming, who sang the National Anthem. There was a food drive for the local Need's Food Bank and everyone making a donation received free admission, a raffle ticket and a slabbed Wyoming Quarter compliments of ICG and Cheyenne Coins LLP. The dealers donated \$125 cash, which was spent on canned food items, and the public made food donations as well. The food bank received over 265 food items. Alan Herbert ("The Answerman") was kept busy answering questions from the bourse floor.

Cheyenne Coins LLP and the Cheyenne Coin Club will host two shows this year. The first show will be a one day show on Feb 9, 2008 from 9:00 AM to 5:00 PM, and the second show will be the 3rd Annual Cheyenne Fall Coin Show, September 19-21, 2008. The show will be bigger and better next year!

New Jersey / YN Programs

Information about YN programs from Jim Majoros

Here are some things we do at our club (The Ocean County Coin Club) that pertain to Young Numismatist (YN) members:

1. We have a 5-page info pamphlet, "Recommendations for Forming and Conducting Club YN Programs." This has been part of my program to assist others interested in YNs. I started this when I was the ANA National YN Coordinator back about 2000-01 and have sent out over 150 copies all over the country. Copies are always available by contacting Jim at OCCC, Inc., 65-16th St., Toms River, NJ 08753.
2. Our club's monthly newsletter, Sand Dollar, has a page devoted to YNs every month. It gives them a homework assignment for which they receive additional club money to use to bid on coins for their collection.
3. In addition, we also publish photos in the Sand Dollar reflecting YNs as a major part of our club. We recently had a page full of photos from the annual "National Kids Night Out," held every August on the Metedeconk bathing beach. We hand out numerous items to many children and recruit a few of them every year.
4. YNs take a separate part in many of the club's activities, such as when we have a Chinese auction, we set up their own table of items. The same holds true for our annual awards banquet when we have two tables for door prizes – one for adults and one for YNs. This creates some additional prestige.
5. At every meeting (we have two a month), there is a free coin auction for the YNs that we set up and have a lot of fun with them. They earn club money in a number of ways, such as exhibits, show and tell, etc. to use for bidding.
6. When we have our National Coin Week Mini-Show, we have about 4-5 YNs set up exhibits and have them judged to give them an idea of accomplishing an exhibit. We also do this for our annual show and all exhibitors receive a one ounce silver round plus any prizes. In addition, at both shows, we set up a YN table with YNs working small coin games along with normal handouts, etc.
7. We also encourage them to write short articles for the Sand Dollar and have an award program for the Literary Award of the Year, one for adults and one for YNs.

8. In 2002, we began a YN of the Year program that goes along with our Numismatist of the Year and these awards are given out at the awards banquet, of which we had 73 attend this year.
9. At the start of the State Commemorative Quarters Program in 1999, our club joined forces with the Vallejo Numismatic Society in California and provided an incentive for our members to take part in a "State Quarter Search Team." Three of the team members were YNs. We sincerely appreciate Michael Turrini's interest and efforts that made us a part of this search. We all had fun.
10. When our club has a guest speaker for the regular meeting that begins at 7:30, we request the speaker to spend about 20 minutes with the YNs to give them an idea of this topic and also give them another personality other than us!
11. At our annual banquet last month, we played "Deal or No Deal" and it was great fun. Used four contestants, one of which was a YN, and we had 6 YNs hold the "numbered cases." Top prize for each was \$25, so max cost was only \$100, but used only \$55. Only took about a half hour and was much better than a guest speaker (in my opinion).
12. We continually stress the availability of the ANA's Ancient Coin and Copper Coin Projects as well as the annual summer seminar courses for scholarships. We did have a YN approved this year, however, he had to back out and will be applying again in 2008.

I am very fortunate to have a YN Director who takes his task very seriously and does an outstanding job. Without his interest, our program would not be where it is today.

In addition, I was so pleased to see the appointment of Jeff Swindling as the ANA YN/Scout National Coordinator.
