15. Add additional day to NMS submitted for consideration by an ANA Member

Add another day to the spring convention. The gathering as now programmed is but a two-day event. Sundays, both at the spring and summer shows are but a courtesy to the public to showcase the hobby with little if any educational activity. An increase in the cost of the show to go to a third day is only about 20%. This 20% buys more than 33% more educational programs, the life-blood of the Association. Adding another day would also relieve the stress of trying to complete all the exhibit judging tasks. The exhibit and student judging are now compressed into a 36-hour time frame allowing little time to enjoy other aspects of the convention. I support the ANA, but is it cost effective traveling across the country for a two-day show? Please consider a third day.

16. Oversight Committee submitted for consideration by an ANA Member

Oversight committee. Some form of oversight in the operation of headquarters should be in place before a new executive director is selected. I don't believe the director should have complete control of headquarters operations without some form of employee access to the Board to vent grievances. I was disturbed in hearing that employee's were requested not to visit hospitalized employees by the former ED, suggesting the employee will get better without visits. This kind of management philosophy is not acceptable. I commend the Board for giving the headquarters employees a yearend bonus. This should be a budget item.

17. Codes of Ethics submitted for consideration by an ANA Member

Codes of Ethics. As the by-laws are now written, there are three Codes; one for members, one for dealers and one for the Board. With the knowledge and wisdom that now constitutes the Board; one code can be written to cover all three.

18. Rewrite rental fee schedule for ANA traveling exhibits submitted for consideration by an ANA Member

Rewrite the fee schedule for the rental of ANA traveling exhibits. As now written, non-member schools receive a lower rental rate than ANA member clubs. I know and realize the reason for the differential in pricing, but I think this is unfair to member clubs. No entity should receive a lower cost than what is extended to the membership.

19. Add numismatic information to the ANA web site submitted for consideration by an ANA Member

There is little actual numismatic information now available on the ANA web site. There are lots of links and references to other sites for information. Please consider establishing a Numismatic Encyclopedia similar to the Wikipedia format.
