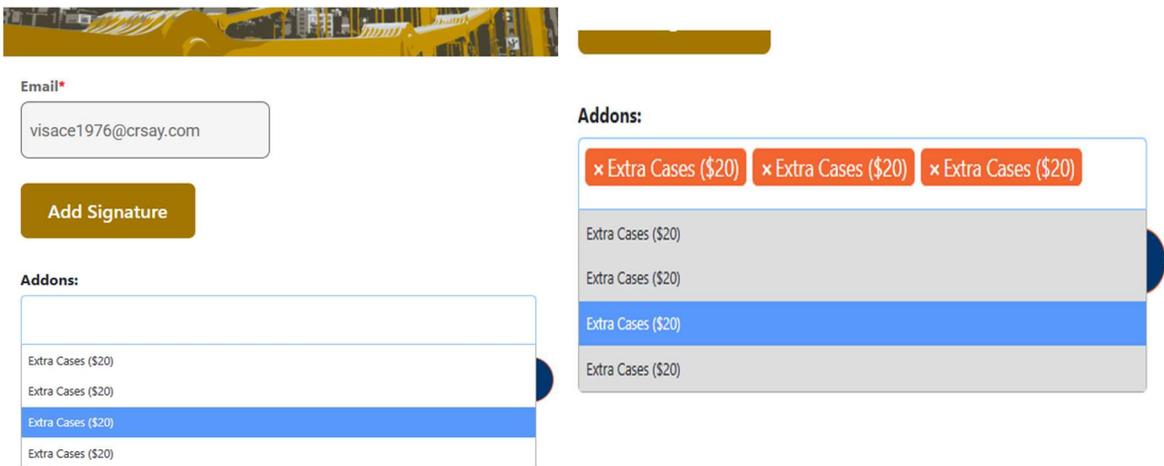
- You should see your email listed in the assignment window. Select your email, unless you are assigning a share dealer, then select add new user.
