Discussion: Treasurer Jansen indicated that he had nothing to report during the open session.

Agenda Item #3 Authorization to Sell Shares of Ben E. Keith Stock - President Tom Uram (231212 OS#2) Amended MOTION by Governor Brush, second by Governor Kraft that the Association will sell 60 shares of Ben E. Keith, Inc. Class A shares after March 2024.

Discussion: Governor Brush advised that preparation for the sale had to start now to be able to get all the approvals prior to the stock sale. The March date allows the ANA to get the dividends from the stock being sold and provides suitable timing for budget needs.

Treasurer Jansen indicated he had proposed selling 75 shares to give the budget a cushion.

Governor Garrett asked whether selling 45 shares provided sufficient funding.

Finance & Budget Committee Chair Baber commented that selling 75 shares was aggressive and suggested selling 60 shares to get necessary funds. He indicated that the sale could be done in July and that the ANA currently has 1034 shares of Keith stock.

Treasurer Jansen advised that he could support selling 60 or 75 shares.
